PAYMENTS & CHARGES

- 1 Monthly Tuition will be automatically drafted from your saved credit card on the 25th of every month. All other payments must be made in one of the following ways.
 - Using a credit card online through your Dance Studio Pro Portal.
 - Paying by check, cash or credit card in the office.
- 2 **Registration fees** must be paid prior to a student registering for classes.
- 3 Fall tuition is charged each month September through June. Monthly tuition fees are calculated for the entire 9.5 months and the same monthly tuition is charged each month without adjustment, regardless of holidays, number of weeks, or when class is last held.
- 4 A discount of 5% is given if either semester is paid in full at registration (semester #1 September-December, semester #2 January-June). A discount of 10% is given if the full dance session is paid at registration (September-June).
- 5 A late fee of \$10 will be charged if a tuition payment is not received by 5 days after the due date.
- 6 All accounts must submit a credit/debit card to keep on file.
- 7 A returned check charge of \$30 will be added to your account if a check is returned for nonsufficient funds.
- 8 A written notice must be given to the office to remove a student from class. You will be charged for all class tuition until a notice is submitted.
- 9 No refunds. No prorating. No returns on any merchandise or costumes. All orders and sales are final.
- 10 No dancer will be permitted to attend class if the previous month's amount due payments (tuition, costumes, special classes, etc.) have not been paid.

CLASSES

- 1 Students must meet minimum age requirement per level.
- 2 Only the Studio Owner can move a student to a higher level.
- 3 Students are in the same level for ALL classes (unless approved by Studio owner).
- 4 The Studio owner has the right to cancel any class with less than 4 registered students.

INJURIES

1 – The Studio KG LLC is not responsible for any injuries or illnesses that may occur. By signing this form, you waive all rights and thereby release and hold harmless all employees, staff, teachers, owners, heirs, and volunteers, from any and all liability.

PHOTOS

1 – Any photos or videotaping taken during The Studio classes or any attended events become the property of The Studio and can be used for promotional purposes without compensation. By signing this form, any photographs, images, videotapes (in whole or in part) may be used in publicizing The Studio in print or electronic media.
